Hello,

I am proud to report that the monthly visitor count continues strong. SCAUWG.ORG is garnering weekly visitor counts in the 800's. Though during the last week in June over 900 visitors stopped by.

The goal is to still publish pertinent aviation airspace safety material, flight educational support, commentary and notices that will benefit the aviator community at large.

It is nice to see that slowly Aviation is making a comeback at this time, with flight schools and businesses beginning to re-open.

This past month SCAUWG has tried to provide a seeming treasure trove of meaningful content.

- Ligado Networks and the static received from various congressmen addressed to the FCC regarding the unusual "weekend approval" for its Ligado Networks 5G wireless network proposal critics say could pose a risk to our GPS system - that might be a topic a SCAUWG committee might want to further address as well.
- The necessary operating rules that apply to VFR flights in controlled airspace when an ATC facility has an unscheduled shutdown are featured.

- Paul Bertorelli's AVweb video that explores emergency landings on beaches versus those on breakers is linked to.
- Coronavirus info from the FAA and a video explain the SFAR that provides relief for certain persons are topics featured.
- Big rate hikes are in the news U.S. Border Protection folks have levied increases at GA Airports – ATC Canada announced 29.5% increases in their service charges as well. We have both stories
- TSA released a guide addressing mitigating insider threats. SCAUWG.ORG has it.
- The NTSB made a plea asking for Helicopter Data and Image logging. The details are on the site.
