Hello,

On August 26 I was the recipient of hundreds of Sexually Oriented Spam Messages apparently sent by offshore sources via the use of our "Contact Us" page. I reported those as phishing. Consequently, our Host server also noted the breach, and independently took the site offline until some repairs can be made that include CAPTCHA revision, etc. Those are in progress.

Unfortunately, the viewable screen just reports, "Access Denied," when someone tries to log on.

Our site content appears undisturbed, and I do maintain a back-up for the site if needed. Iono provided an analysis of the problem, where the spam originated, what needs to be addressed, and the "how-to" instructions in order to restore site access, which hopefully the technical expert will enable soon.

Other than that...

I am proud to report that the monthly visitor count continues strong at SCAUWG.ORG The Monthly Result ending 7/31/2020 for the month of July reported 4481 monthly visitors. During the first week of August we saw 969 site

visitors.
