Last month I was happy to report that we had a two weeks with visitor counts just over 900 each. And the 30 day month totaled just less than 4000. Since then, visitor growth has continued. Last week our count was 967, and based upon that a 31-day month count this month might be well over 4000.

Last month the original SCAUWG.ORG apps ChartAware and ChartCompare were both upgraded by cartographer and contributing editor Mike Carson, Mike compiled the current record of ChartAware “hits.” The report indicates that ChartAware January through November was visited 4646 times, and those visitors performed 78,627 operations.
