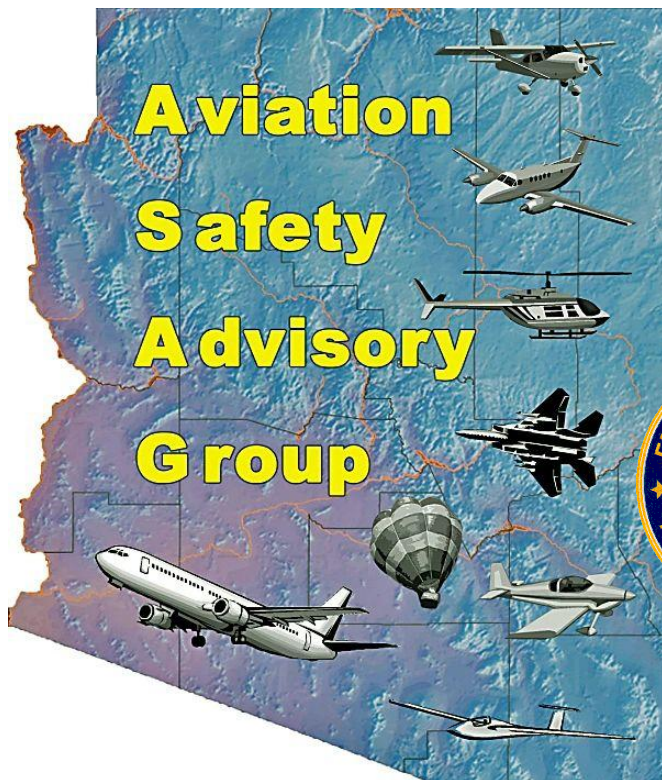

Keynote Speaker – Bob Mittelstaedt



Bob studied Mechanical Engineering at Tulane University and, through NROTC, earned his Private Pilot License and a Navy officer commission. After five years "seeing the world" on nuclear submarines he left active duty for The Wharton School and an MBA. Then, while with a consulting firm for two years he resumed flying and earned Commercial, Multi-Engine and Instrument ratings. He then returned to Wharton for a 31-year career in Philadelphia while co-owning airplanes and flying for business and family vacations all over the country.

He was a consultant to the Nuclear Regulatory Commission to help design the investigation of the Three Mile Island nuclear accident. This spurred interest in accident chains in a variety of situations and industries, including aviation. He collected examples for years; tested concepts with executives and in 2004 wrote *Will Your Next Mistake Be Fatal? Avoiding the Chain of Mistakes That Can Destroy Your Organization*. The book includes several aviation mistake chain accidents.

From 2004 to 2013, Bob was the Dean of the W. P. Carey School of Business at ASU. Over 40 years he served on numerous boards of directors and was a founding investor and board member of Innovative Solutions & Support, a mid-size avionics company, providing support for military, commercial and business aviation markets.

He has volunteered with the Deer Valley Pilots Association and as the AOPA Airport Support Network Volunteer at DVT for over 15 years. He is a recipient of the FAA's Wright Brothers Master Pilot Award.

His talk will address the importance of identifying and mitigating mistakes with Crew Resource Management, especially for single pilot operation with a non-pilot spouse or companion. Real life personal examples, audience interaction, and a quiz for the chance to win a prize (without requiring you to admit any mistakes) will be part of the presentation.

Updates from Community Representatives



Major Shannon Smith, Luke AFB Chief of Flight Safety

Major Shannon Smith shared a [Slide Show](#) about Luke Assigned Aircraft Arrivals.

Luke AFB Arrivals

[COPPA](#) and [CBANA](#) fixes are where Luke aircraft return to Luke AFB. This is where they encounter other traffic.

Cary Grant: Gila Bend is a popular place for student solo cross countries. Also, COPPA and CBANA are in Rainbow Valley and that is where Goodyear flight schools (United Aviate Academy) train their pilots.

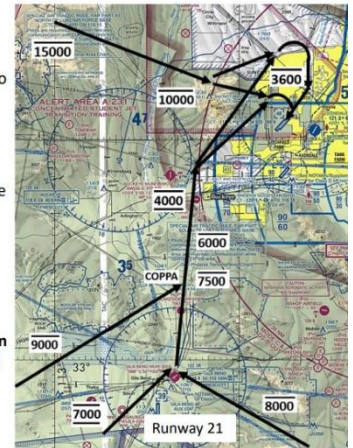
Major Smith: Our aircraft are not equipped with ADS-B. We are attempting to contact the schools at Goodyear where we can make presentations.



Arrivals from the south (Valley Recovery) funnel to COPPA (GBN351/13) enroute to Luke

Arrivals from the north (Tankz Recovery) enter the Luke Traffic Pattern from northwest of the White Tank Mountains

Contact Luke Approach on 118.15 (north) OR 125.45 (south) for advisories



Cary: Rainbow Valley flight school pilots need to announce their position on the Rainbow Valley frequency, 128.925.

Bob Katz asked if COPPA and CBANA are charted. **Major Smith** replied that they are not charted because it's strictly a Luke VFR arrival.

Major Smith: Air Force fighter aircraft have been granted an ADS-B waiver for national security reasons. Other Air Force such as KC-135s, T-38s and C-17s have ADS-B out.

Cary: East of COPPA is Bishop, and the Bishop jump pilots will be talking with Phoenix Approach.

Thomas Cowan suggested that Major Smith plan to attend Thomas Cowan's Jump orientation seminars that are presented at various Valley flight schools. Major Smith could attend and present either in person or via Zoom. A March Jump seminar is planned for Marana.

Cary asked about the status of [Luke Aux-1's ILS](#)? **Maj Smith** stated it is not in operation.

Maj. Smith to Neil Davison: No balloon issues. For the F-35, there is more situational awareness, and balloons are easier to see than aircraft and UAS.

Ernest Copeland: After the passing of Craig Tompkins, it will take a while to catch up on Lasers Strikes and UAS problems, but Ernie will have a report next month.

Scott Woodworth to Major Smith: Drones shouldn't be any higher than 400' AGL. USAF has encountered UAS traffic at and above 6,500' MSL – way above 400' AGL.

Ways for Pilots to Report Laser Incidents – Cary Grant:

Tell us where the Laser event happened. Was it at a gas station, intersection, etc.?

1. Hit the transponder identification button as soon as pilots are aware of being Lased. This will mark the plane's position on the air traffic controller's radar scope, which may help law enforcement triangulate where the laser light is originating from.

2. Verbally alert ATC of the attack using the phrase "laser attack," including direction and location of the laser source, beam color and length of exposure (flash, pulsed or perceived intentional tracking).

3. Once on the ground, complete the [FAA-requested Laser Beam Exposure Questionnaire](#).

Upon arrival at destination, all pilots and crew members affected by an unauthorized laser illumination are requested to complete the FAA Laser Beam Exposure Questionnaire in order to provide critical information in support of law enforcement efforts to identify and apprehend the responsible parties.

If you are a member of the public who witnessed an individual aiming a laser at an aircraft, send an e-mail to laserreports@faa.gov and include the following: Your name and contact information. Date and time you witnessed the laser incident.

When you file a Laser Strike report, you are asked if the strike had an effect on your performance as a pilot during the flight. **You need to answer "Yes."** If you report "No," then a regulatory violation did not occur, and your Laser Strike report will not be investigated by the FAA.

CW5 Chris Hammond: Normal annual training.

Not every military aircraft has ADS-B, but the Rotor Act has passed the US Senate. (Written after the Regan Airport Crash). It requires that all aircraft have

ADS-B in and out by 2031.

Cary Grant: Please treat Picacho as if it were Class Delta.

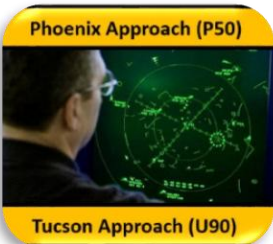

(d) **Communications with control towers.** Unless otherwise authorized or required by ATC, no person may operate an aircraft to, from, though, or on an airport having an operational control tower unless two-way radio communications are maintained between that aircraft and the control tower.

Class Delta airspace is usually an area extending from the surface up to a specified altitude (often 2,500 feet AGL), with a standard radius of 4.4 nautical miles (5 statute miles) around an airport with an operating control tower.

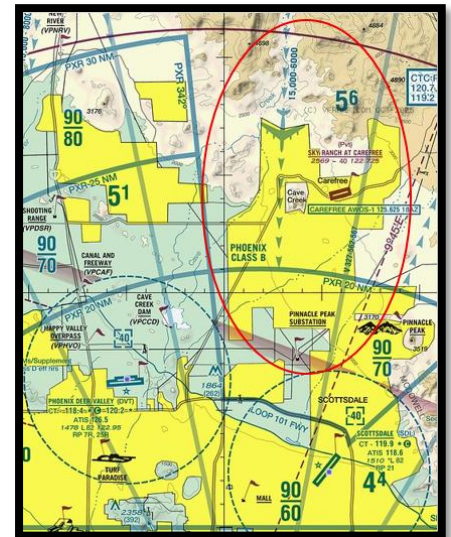

Matt Schorman: With the Barrett Jackson Car Show and Auction, Scottsdale is very busy – almost busier than PHX. Pilots need to avoid six miles either side of the Sky Ranch corridor.

Snowbirds, those who don’t know about the need to avoid maneuvering in the zone, are maneuvering in the Carefree area. We have had quite a few loiterers doing Lazy 8s and Chandelles in the area. This is causing many **TCAS** Resolution Advisories (RAs).

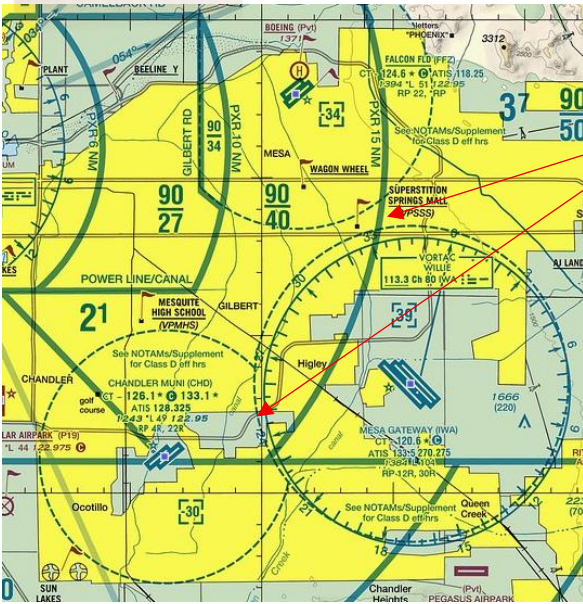
Matt Schorman said it’s status quo at U90 (Tucson Approach).



Casa Grande Approaches: Lee Unger would like the FAA to consider **not** allowing IFR approaches in VFR conditions at Casa Grande (CGZ).



Notice of Proposed Rule Making (NPRM) - Increasing Chandler's Delta altitude and increasing the area of Gateway's Delta. The FAA airspace managers, to accommodate a rarely used instrument approach at Chandler, want to increase Chandler's Delta ceiling up to but not including 3,400' MSL to "up to **3,700' MSL**. Note: The Base of the Bravo is 4,000' MSL. [CLICK HERE TO READ MORE & COMMENT ON THE PROPOSAL](#)



They also want to increase the footprint of Gateway's Delta, which would remove "the gap" between Gateway's Delta and Falcon's Delta.

It would also increase its presence in Chandler's NE Delta.

The name and geographic coordinates of the Mesa Gateway Airport would also be updated to coincide with FAA's aeronautical database.

The FAA is proposing this action due to biennial airspace reviews, to support instrument flight rule (IFR) operations, and to bring the airspace into compliance with FAA orders.

Cary Grant: This will shut off VFR departures unless the pilot contacts the appropriate Tower for clearance.

ASAG Accident & Deviation Report

Mid-DEC through **Mid-JAN** 2026

Accident Report & Pilot Deviation Summary



The following are the reports of aviation accidents, and incidents that have occurred in Arizona from mid-December through mid-January. The Accident Report will be limited in size because of the unexpected, and sudden passing of Craig Tompkins of the FAA SDL FSDO. Craig always provided the substantial FAA input to the Accident/ Incident report, and all the information for the Pilot Deviation, and NMAC Reports.

We hope to use the following detailed accident information to develop safety programs, briefings, and posters/flyers that would help pilots learn from the mistakes being made by others and be able to take the necessary action to prevent them from having a similar occurrence.

The Accident/Incident report is short as there were only eight accidents reported this time.

In continuing with the expanded scope of this report, we're using information from the Aviation Safety Network (ASN), NTSB, and APA Members. Hopefully, the information from these sources will suit our purpose of trying to get an idea of what is happening out there so we can help make flying safer.

12/7 RotorWay Executive 162 F Helicopter LANDING ACCIDENT at Chemehuevi (Chem-eh-Way-Vee) Valley Airport (49X)

The helicopter departed Lake Havasu Airport for Chemehuevi Valley Airport, and during the landing, the helicopter was involved in a landing accident.

The Swearingen Metro suffered a runway excursion on takeoff for Phoenix Sky Harbor. The aircraft was accelerating down the runway when at about 65 knots, the aircraft veered off the runway. The pilot managed to make it back to the runway, but the aircraft became disabled.

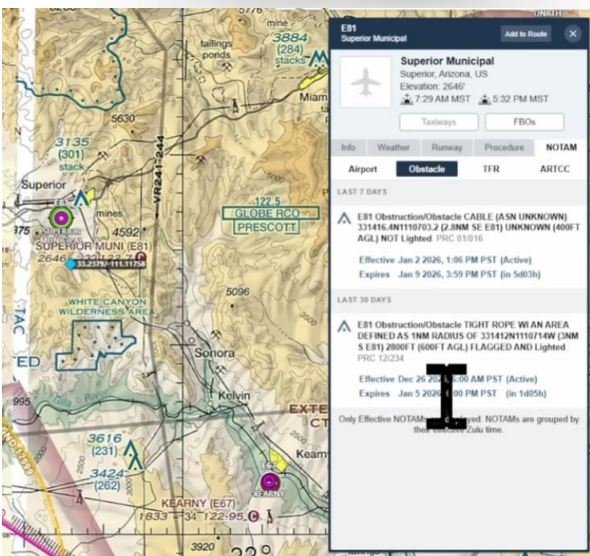

The helicopter departed Pegasus Airpark and struck a slackline between two mountains, crashing into a mountainous area south of Superior.

< After touching the Superior Muni runway symbol, this is what the NOTAM would have indicated on ForeFlight. NOTE: It was listed under Superior Airport and the Slacklike was not at Superior Airport.

After the accident, the NOTAM was removed.

Cary wondered why ADS-B cannot be attached to a Slackline? **Fairfax O'Riley** said that ADS-B installation needs to be attached to **an aircraft**.

Neil Davison: We cannot put ADS-B in a balloon.

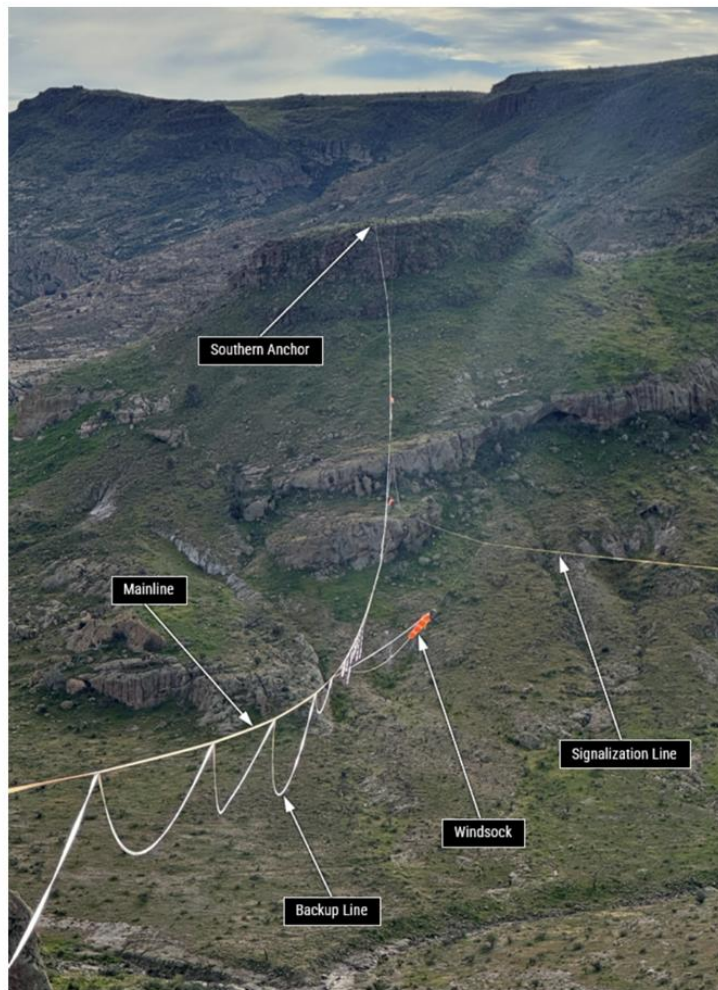


Figure 1: The series of lines between the anchors, as viewed from the northern bluff (photo courtesy of witnesses).

On or about December 30, 2025, high winds and rain were predicted near the accident site, and the slackliners chose to lower the mainline and backup line. On the morning of the accident, the weather had improved, and the slackliners began to draw the mainline and backup line from the northern anchor toward the southern anchor.

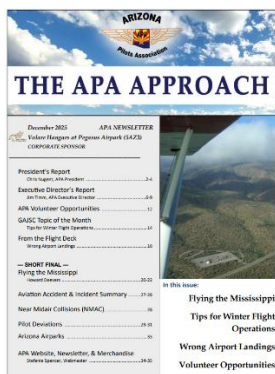

Chris Nugent, President of Arizona Pilot's Association (APA), discussed the Falcon Field (FFZ) Landing Fee issue driven by the Mesa City Council.

Chris: The city has moved the City Council vote from Feb 9, forward an additional 45-60 days.

Otto put together a proposal. There will be a follow-up meeting this afternoon. **Cary:** Caution on involvement. If you are at a City Council Meeting, don't speak on behalf of ASAG or APA.

CJ deVries, John Keith, Chris Nugent. House Bill 2210 – (Barring Airports from using ADS-B to bill for Landing Fees)

CJ: House Bill 2210 is currently going through the Arizona State Legislature. This bill would bar airports from using ADS-B to bill pilots/owners for landing fees. The bill has been assigned to a committee and then will be voted upon by legislature. We are early in the process. Indications are that there is great support.

Cary asked **CJ** to stay in contact **John Keith** (our liaison with Senator Rogers).

Cary: Pilots cannot turn ADS-B OFF to avoid a Landing Fee bill. That would be a violation of FARs.



C J deVries cj@dvluxury.com is working with legislators to prohibit the use of ADS-B to calculate, generate, or collect fees from aircraft owners or operators while operating in Arizona airspace.

He is getting support from the Legislature and pilots.

Letters to Airmen (LTA) for the Stacks at Casa Grande/Stanfield and Coolidge - Lee Unger, representing the Stacks LTA Workgroup

LTA for Coolidge and Casa Grande – still in the hands of ABQ center.

Lee Unger has asked Albuquerque Center to consider not allowing **IFR operations**, including **transiting traffic**, in VFR conditions within 15 nm of CGZ, below an altitude P50 and ZAB

ARTCC consider as workable, possibly 8,000 MSL. Coolidge P08 would have similar restrictions with distance and altitude to be determined.

This would eliminate dangerous conflicts between IFR operations and VFR traffic in the stacks.

Matt Schorman said having no IFR operations might be an issue for some business flights.
